Agenda Item: Resolution to approve the updated Schedule of Fees and Fines being recommended by the Municipal Court Judges

City Attorney's Recommendation:

The City Attorney recommends approving this schedule as provided by Section 30-5 of the Code of Ordinances of the City of Sandy Springs and also recommends authorizing the Municipal Court Clerk to adjust the state-mandated surcharges and fines reflected on the list as may be made necessary from time to time by subsequent changes in State law.

Background:

Section 30-5 of the Code of Ordinances of the City of Sandy Springs provides as follows: "(a) The municipal court judges may recommend a schedule of fees to assist the court in its operation and budget. The council must approve any such schedule, but if the council does not act within 30 days of the court's recommendation, the fee schedule will become effective."

The administrative fee was last reviewed by Council in 2014. The state misdemeanor violations set forth in the list were last updated in 2006.

Discussion:

Since 2006, there have been changes in the state laws governing certain of these offenses which need to be incorporated into the list, both as to the offense itself, as well as the fine amount.

This list serves several important purposes. All ordinance violations require an appearance in municipal court, but these state violations do not and individuals may choose to pay the listed fine rather than appearing in court. Further, while having discretion in setting fines within the parameters set by state law, the list provides uniform guidance to the municipal court judges.

Moreover, the \$78.00 administrative fee being recommended is supported by an analysis of the Court's operating expenses.

Alternatives:

The alternative would be not to approve the schedule, but recognizing that it is bringing the listed fines into compliance with state law, as well as the violations and Georgia Code section references, this is not a recommended alternative. Additionally, the administrative fee being proposed is based upon an analysis of the Court's operating expenses and serves the purpose intended by Section 30-5 of the Code of Ordinances of the City of Sandy Springs.

A RESOLUTION TO APPROVE THE UPDATED MUNICIPAL COURT SCHEDULE OF FEES AND FINES BEING RECOMMENDED BY THE MUNICIPAL COURT JUDGES

WHEREAS, pursuant to Section 30-5 of the Code of Ordinances of the City of Sandy Springs the municipal court judges may recommend a schedule of fees to assist the court in its operation and budget; and

WHEREAS, the Council has previously imposed Municipal Court administrative fees by prior resolution; and

WHEREAS, the schedule of fines for state misdemeanor violations was last updated in 2006 and the administrative fee was last reviewed by Council in 2014; and

WHEREAS, there have been changes in the state laws governing certain of these offenses which need to be incorporated into the list, both as to the offense, as well as the fine amount; and

WHEREAS, the operation costs of the Municipal Court have been determined and the Municipal Court judges wish to modify the administrative fee to defray the Court's costs more accurately and reasonably.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANDY SPRINGS, GEORGIA

The City of Sandy Springs Mayor and Council approve the attached Schedule of Fees and Fines and in particular authorize the Municipal Court to collect an administrative fee as follows:

Section 1. The Municipal Court administrative fee shall be set at \$78.00 for each case which is disposed of by: (a) conviction after trial; (b) accepted plea of guilty; (c) accepted plea of nolo contendere; (d) any bond forfeiture or voluntary payment of fine as set forth on the attached list. This administrative fee shall apply and remain in effect until modified or amended by recommendation of the Municipal Court Judges and approved as provided by Section 30-5 of the Code of Ordinances of the City of Sandy Springs.

Section 2. The Municipal Court Clerk is authorized to adjust the state-mandated surcharges and fines reflected on the list as may be made necessary from time to time by subsequent changes in state law.

Section 3. This Resolution shall become effective September 1, 2016, and supersedes all prior resolutions establishing Municipal Court administrative fees and prior Schedules of Fees and Fines. All resolutions conflicting therewith are hereby repealed.
